WHEREAS, the Autauga County Commission hereby authorizes the commitment of necessary cash match relating to the FY2025 EDA Disaster Supplemental Grant Project for a I-65/US-31 interchange and surrounding area comprehensive economic development analysis.

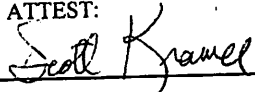
SECTION 2. HEREWITH, the Autauga County Commission is empowered to execute the documents necessary to apply for and, if awarded, accept EDA grant funds;

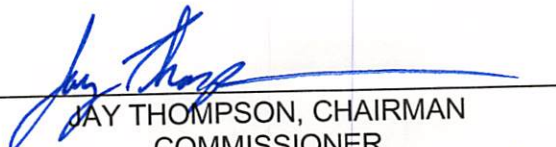
