RESOLUTION 2024-7

COMMEMORATING THE JANUARY 12, 2023, EF3 TORNADO AND HONORING VICTIMS AND THEIR FAMILIES

WHEREAS, various communities in Autauga County were devastated when they were hit on January 12, 2023, by an EF3 rated tornado, which will be marked by a one-year anniversary on Friday, January 12, 2024;

WHEREAS, the tornado caused significant property damage throughout large portions of Autauga County;

WHEREAS, we recognize those whom lost property in the storm, many of whom continue to this day to put their lives back together;

WHEREAS, though the property damage was devastating, the Autauga County Commission recognizes that the citizens of Autauga County are our County's greatest resource;

WHEREAS, the people of Autauga County are continually devastated that, among the injuries to numerous citizens, seven Autauga Countians lost their lives due to the tornado's destructive force;

WHEREAS, those who lost their lives in Autauga County include Carmen Cox Autery, Christopher Allen Corbin, Jr., Deanna Marie Corbin, Tessa Celeste Dcsmet, Robert Gardner, Jr., Solomon A. Smith, and Andrea Sue Taylor;

WHEREAS, the people of Autauga County still deeply grieve the shocking loss of life and adjust to a new reality after the events of January 12, 2023;

WHEREAS, it is good, right, and proper for the Autauga County Commission, the citizens of Autauga County, and the people of Alabama to continue mourning and commemorate the devastating loss of life and property experienced January 12, 2023;

WHEREAS, Autauga County Commission Chairman Jay Thompson has requested Governor Kay Ivy to honor the loss of life and property in Autauga County, and in other parts of our state, by ordering flags throughout Alabama to be flown at half-staff on January 12, 2024, the one-year anniversary of the tornado.

NOW, THEREFORE BE IT RESOLVED, that the Autauga County Commission, on behalf of all the citizens of Autauga County hereby:

- 1. Solemnly commemorates the January 12, 2023, tornado outbreak in Autauga County;
