
WHEREAS, Autauga County, Alabama works through and with the other local entities as part of an economic development team to attract and retain economic development; and

WHEREAS, the team has met and recommended incentives for Project Mayfield for the purpose of economic development in Autauga County, Alabama; and


NOW, THEREFORE, BE IT RESOLVED that Autauga County concurs that an incentive package be offered.
