WHEREAS, Chief Brown worked his way up through the ranks proving his commitment to his fellow firefighters and to the citizens of Prattville and Autauga County; and

WHEREAS, Chief Brown became Sergeant/Driver Operation in 1990 and Lieutenant in 1997; and

WHEREAS, Chief Brown became Captain in 2000, then in April 2002, was promoted to Division Chief and Fire Marshal; and

WHEREAS, Chief Brown became the department's first Deputy Fire Chief in 2007; and

WHEREAS, Chief Brown became Fire Chief in September 2012; and

WHEREAS, Chief Brown, worked under Chiefs Donald McGough, Archie Plyler and Stanley Gann, and during the tenures of Mayors Gray Price, David Whetstone, Jim Byard, and Bill Gillespie, Jr.; and

WHEREAS, the Prattville Fire Department made significant progress under his leadership and guidance and Chief Brown has been a helpful partner to Autauga County; and

WHEREAS, under Chief Brown's leadership, Prattville Fire Department provided countless hours of mutual aid to Autauga County; and

WHEREAS, Chief Brown fostered a positive working relationship between the Prattville Fire Department and First Responders throughout Autauga County; and

WHEREAS, on August 20, 2024, Prattville Fire Station Number Four was named the Chief Terry D. Brown Fire Station in his honor.

Brown. NOW, THEREFORE BE IT RESOLVED, by this Resolution that the Autauga County Commission hereby designates Scott Kramer, Administrator, to serve as the Public Officer of Autauga County to carry out the directives of the Open Records Act, as amended by Act No. 2024-278, as they pertain to public records in the custody and control of the Commission and to develop and recommend to the Commission from time-to-time the adoption of procedures for accepting Public Records Requests.






