Remarks Map 21-4, 22-6, & 22-7 are waiting on Traffic Stripe to be paid in FY 2023.
 Map 22-3 is a Federal Aid Project currently under construction. It's utilizing \$257,609.87 of Federal Aid Funds and \$278,754.47 of CRAF. Estimated final project cost of \$536,364.34. Any overruns will be paid out of CRAF
 Map 22-5 is currently under construction and no payments have been made yet. This project let for \$284,470.60 and any overruns will be paid out of CRAF.
 Map 20-5, 21-5, & 21-7 are apart of a 13.58 mile Chip Seal project including CR-22, CR-74, & Riverview Ln and is scheduled to be let in FY 2023. Map 22-2 is a federal aid project scheduled to be let in FY 2023
 Map 22-9 was awarded \$173,348.82 from the Rebuild Alabama Annual Grant Program. Total construction cost was \$138,930.14
 Map 20-3, 20-5, 21-2, 21-4, & 21-5 are carryover projects from previous fiscal years. Map 22-1, 22-4, & 22-8 will be carried over to FY 2023
 Public Works Projects are covered under Bid Inquiry 2021 - PW1 and 2021-PW2. Competitive Bids are covered by Bid Inquiry 2021-02 and 2021-04. No CTP Amendments were made in FY 2022
