WHEREAS, the Autauga County Commission has agreed to expend certain funds for the widening and resurfacing of Old Ridge Road; and

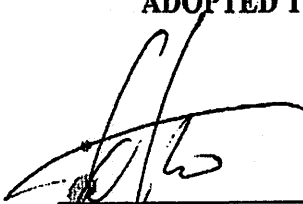
WHEREAS, this will be a joint project between the Autauga County Commission and City of Prattville; and

WHEREAS, a Memorandum of Understanding between Autauga County and the City of Prattville is necessary to delineate responsibilities, liability, and financial obligations; and

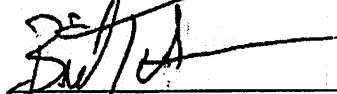

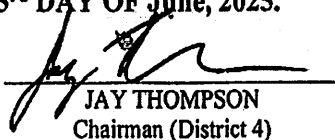

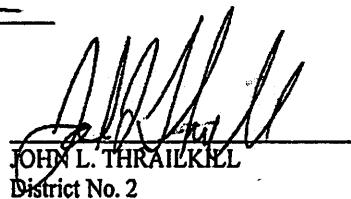

District No. 1



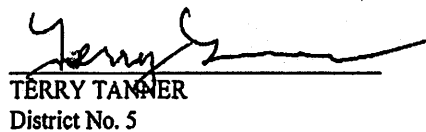

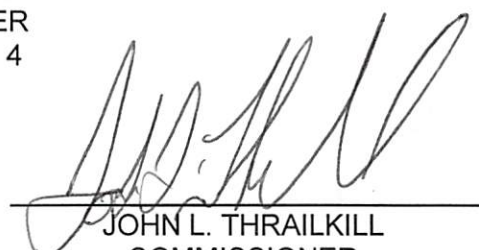
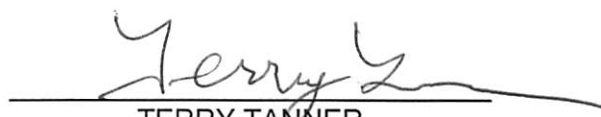
