WHEREAS, we note the death of longtime Autauga County resident Daniel "Danny" Wayne Jones, Senior, with deep sadness and regret, as his immeasurable life is to be commended and celebrated with great thanksgiving; and

WHEREAS, the passing of Danny Jones leaves a void in the lives of his loving family, many friends, the City of Prattville Police Department, the Autauga County Sheriff's Office, and indeed in the entirety of Autauga County; and

WHEREAS, as a true public servant, Mr. Jones couldn't give up law enforcement after his retirement from the Prattville Police Department and went on to serve ten years as an Autauga County Deputy Sheriff; and

WHEREAS, Danny, known by many as Doc, will be missed as a smiling and warm face at the entrance of the Autauga County Courthouse, where he served as a member of courthouse security: and

WHEREAS, Mr. Jones was an avid hunter and fisherman and enjoyed spending time with his family, especially at the beach during the summer; and

WHEREAS, Mr. Jones was a member of East Memorial Baptist Church and was known to enjoy reading and studying the Bible; and

WHEREAS, Mr. Jones' immeasurable commitment to and legacy of community and public service will be hard to match and will live on as an inspiration to us all to serve and support the community where we live.

NOW THEREFORE BE IT RESOLVED, while grieving Daniel Wayne Jones, Senior's death, we are incredibly grateful for his abundant life and meritorious service to the citizens of Prattville and Autauga County.
