NOW, THEREFORE, BE IT RESOLVED, that the Autauga County Commission hereby commits the amount of \$ 147,292.00 as local non-federal match for operations, administration, planning, and capital expenditures under the Section 5311 Rural Area Public Transportation Program during Fiscal Year 2026.

SECTION 5311 AUTHORIZING RESOLUTION

Resolution No. 2025-10

Resolution authorizing the filing of an application with Department of Transportation, United States of America, and the Alabama Department of Transportation for a grant under the Federal Transit Act.

WHEREAS the Secretary of U.S. Department of Transportation and Director of the Alabama Department of Transportation are authorized to make grants for a public transportation program;

WHEREAS the contract for financial assistance will impose certain obligations upon the Applicant, including the provision of its local share of the project costs in the program;

WHEREAS it is required by the U.S. Department of Transportation in accord with the provisions of Title VI of the Civil Rights Act of 1964, that in connection with the filing of an application for assistance under 49 USC Section 5311 the applicant gives an assurance that it will comply with Title VI of the Civil Rights Act of 1964 and other pertinent directives and the U.S. Department of Transportation requirements thereunder; and

WHEREAS, It is the goal of the Applicant that disadvantaged business enterprises (minority business enterprises and woman business enterprises) be utilized to the fullest extent possible in connection with this/these project(s), and that definite procedures shall be established and administered to ensure that disadvantaged business enterprises (DBEs) shall have the maximum feasible opportunity to compete for contracts and purchase orders when procuring construction contracts, supplies, equipment contracts, or consultant and other services.

NOW, THEREFORE, BE IT RESOLVED BY Autauga County Commission

- 1. That Autauga County Commission is authorized to execute and file (an) application(s) on behalf of Autauga County Commission with the Alabama Department of Transportation to aid in the financing of administration, planning, capital and/or operating assistance projects pursuant to 49 USC Section 5311, the Alabama Public Transportation Grant Program, and the Alabama Seniors and Disabled Transit Fare Assistance Program.
- 2. That Autauga County Commission is authorized to execute and file with such applications an assurance, or any other document required by the U.S. Department of Transportation and the Alabama Department of Transportation effectuating the purpose of Title VI of the Civil Rights Act of 1964.
- 3. That Autauga County Commission is authorized to furnish such additional information as the U.S. Department of Transportation and the Alabama Department of Transportation may require in connection with the application for the Program of Projects submitted to FTA.
- 4. That Autauga County Commission is authorized to set forth and execute affirmative disadvantaged business enterprise policies in connection with any procurements made as part of the project.
- 5. That Autauga County Commission is authorized to execute grant agreements on behalf of Autauga County Commission with the Alabama Department of Transportation for aid in the financing of the administration, planning, capital, and/or operating assistance projects.

RESOLUTION 2025-8 FOR THE OBLIGATION OF AMERICAN RESCUE PLAN ACT FUNDS

WHEREAS, Autauga County, Alabama (the "County") received an award of American Rescue Plan Act State and Local Fiscal Recovery Funds ("ARPA Funds"); and

WHEREAS, in accordance with the provisions of Final Rule published by the United States Department of Treasury dated January 6, 2022, the County duly elected to designate a standard allowance of \$10,000,000 of its ARPA Funds as revenue replacement ("ARPA Revenue Replacement Funds"); and

WHEREAS, the County's ARPA Revenue Replacement Funds may be used to cover the costs the County typically bears to provide government services, including renovations to County facilities to ensure the effective delivery of these services; and

WHEREAS, the balance of the County's ARPA Funds not designated as ARPA Revenue Replacement Funds ("Enumerated Uses Funds") may be used for projects to address the negative public health impacts of the COVID-19 pandemic, including eligible capital improvements to County-owned facilities to address these impacts; and

WHEREAS, the Autauga County Commission (the "Commission") has determined that the Autauga County Jail facility is in need of improvements to both facilitate the delivery of government services and address the negative public health impacts of the COVID-19 pandemic; and

WHEREAS, on November 20, 2024, the Commission entered into a contract with Matthes Parker, LLC, in the amount of \$15,596,000.00 to undertake and complete these improvements (the "Contract"); and

WHEREAS, the Commission has determined that utilizing the remaining unobligated balance of the County's ARPA Revenue Replacement Funds to cover the cost of capital improvements to be undertaken pursuant to the Contract that will facilitate the delivery of government services at the Autauga County Jail is a necessary, reasonable, and proportionate measure to facilitate the provision of these government services; and

WHEREAS, the Commission has determined that utilizing the remaining unobligated balance of the County's Enumerated Uses Funds to cover the cost of capital improvements to be undertaken pursuant to the Contract that will address the negative public health impacts of the COVID-19 pandemic is a necessary, reasonable, and proportionate measure to address these impacts.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION as follows:

- 1) The County shall use the remaining balance of its unobligated ARPA Revenue Replacement Funds in the amount of \$2,516,502.00 to cover the cost of capital improvements to be undertaken pursuant to the Contract that will facilitate the delivery of government services at the County Jall. Notwithstanding the foregoing, should the unobligated balance of the County's ARPA Revenue Replacement Funds be in excess of \$2,516,502.00, these excess funds shall also be allocated to and expended for the purpose authorized in this paragraph.
- 2) The County shall use the remaining balance of its unobligated Enumerated Uses Funds in the amount of \$466,968.48 to cover the cost of capital improvements to the Autauga County Jall to be undertaken pursuant to the Contract that will address the negative public health impacts of the COVID-19 pandemic. Notwithstanding the foregoing, should the unobligated balance of the County's Enumerated Uses Funds be in excess of \$466,968.48, these excess funds shall also be allocated to and expended for the purpose authorized in this paragraph.
- 3) The ARPA Program Director is charged with ensuring that ARPA Funds allocated herein will not be used in such a way as to frustrate COVID-19 mitigation guidance issued by the Centers for Disease Control, or for any other use prohibited by the Final Rule or any applicable state or federal law.
- 4) Expenditure of these funds, as authorized by this Resolution, shall be contingent on the continued appropriation and availability of ARPA Funds for the purposes stated herein and in no event shall be used for any expenses not obligated by December 31, 2024, and expended by December 31, 2026.
